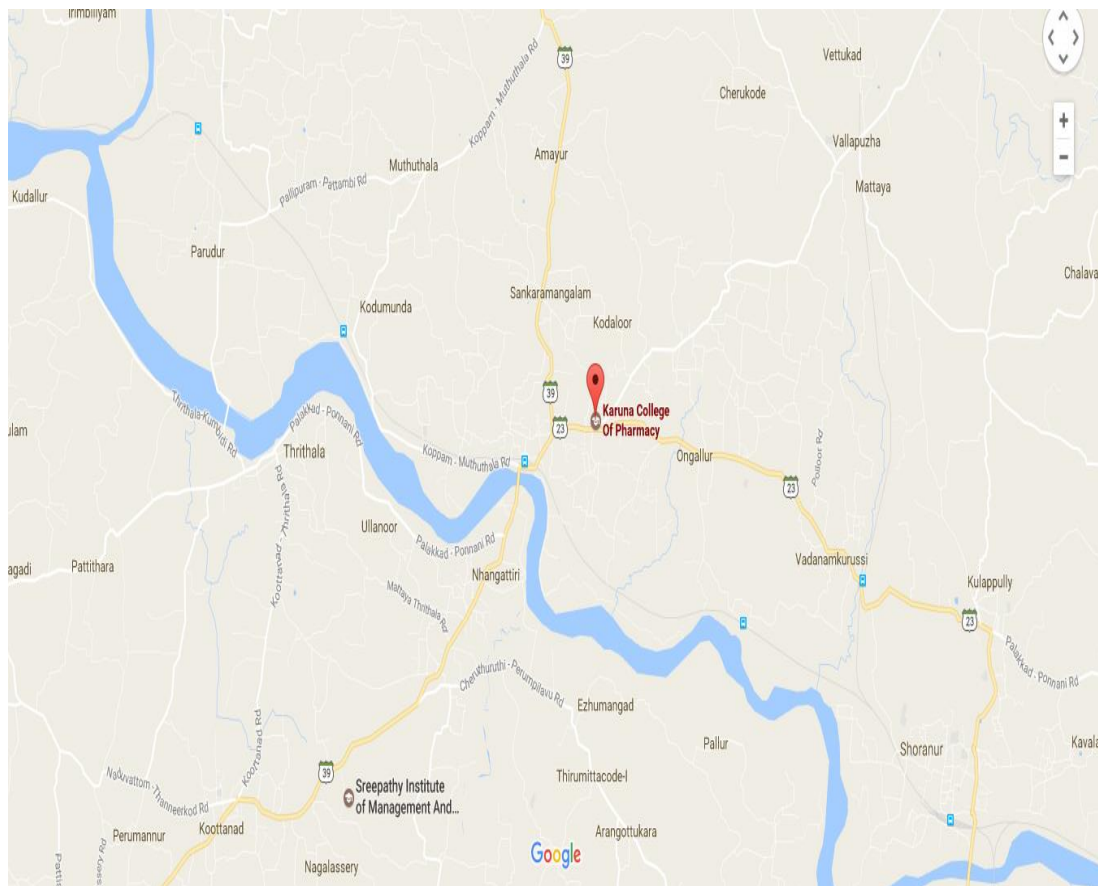

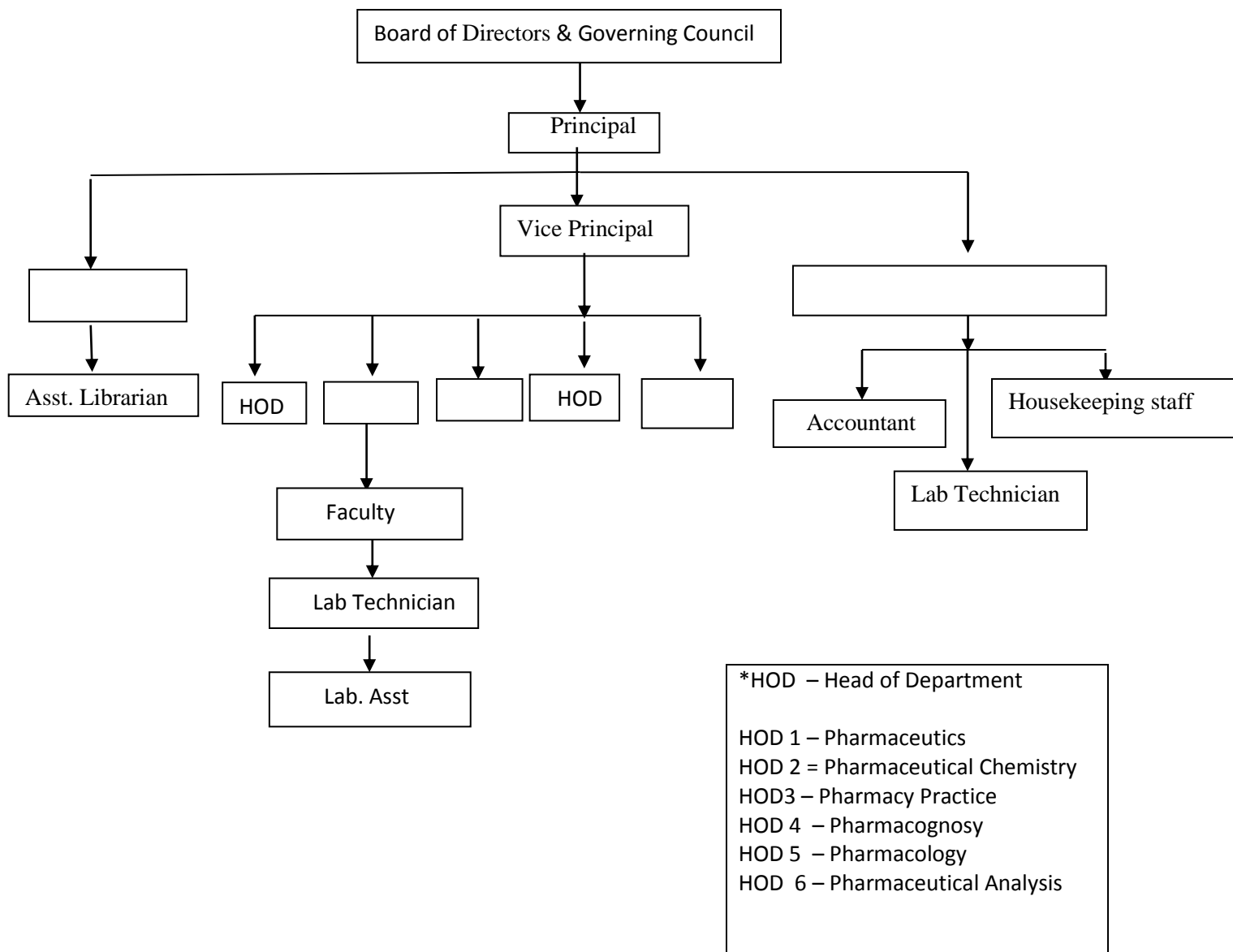

## **CRITERIA OF ELIGIBILITY FOR ADMISSION UNDER MANAGEMENT CATEGORY**

- Candidate must be a citizen of India. A pass in 10+2 Senior Secondary School Certificate Examination or recognized as equivalent examinations with Mathematics as a subject.
- Aggregate percentage shall be 50% for 10+2 examinations. (Minimum marks in Physics, Chemistry and Mathematics should be 50%)
- Minimum marks for mathematics in 10+2 examinations shall be 60%. (Desirable)
- Applicant should have completed 17 years of age as on 31st December 2016. No relaxation of age will be allowed.
