Taking these mission objectives into considerations, the following Research Policy is implemented.

## 1. Purpose

The purpose of the Research Policy is to create a vibrant atmosphere of research among faculty and researchers in Karuna College of Pharmacy. The policy shall serve as an overall framework within which research activities may be carried out.

## 2. Scope

This Research Policy is implementable in all campuses that collaborate with Karuna College of Pharmacy in India and institutions with which affiliating University has signed MOUs.

# 3. Objectives

- To create an enabling environment within Karuna College of Pharmacy in order to foster a research culture as well as provide required support through research framework and guidelines.
- To ensure high level of efficient and effective support system to facilitate faculty and researchers in their research activities.
- Ensure publications in quality journals, indexed in Scopus/Web of Science and/or with impact factor.
- To nurture an environment of undertaking socially useful research with potential for commercialization.
- Establish Research Centers within Karuna College of Pharmacy with potential for Excellence.
- Forge interdisciplinary collaborations and partnerships nationally and globally.

# 4. Custodian of Policy

The implementation and updating of Research Policy shall be carried out by Directorate of Research, Karuna College of Pharmacy. The Research Policy shall have a research advisory body to function under Principal, Karuna College of Pharmacy and administrative committee, to assist and advise in matters related to research within Karuna College of Pharmacy.

# **5.** Policy and Guidelines

• 5.1 <u>Undertaking Research</u>

Faculty members of Karuna College of Pharmacy and research departments are expected to undertake

research, leading to quality publications, presentations in national/international conferences of repute, generation of Intellectual property with potential for commercialization, socially useful outcome and other similar research activity.

• 5.2 <u>Obligations of faculty and researchers</u> Research output will be considered one of the criteria for faculty recruitment and promotion along with other

academic responsibilities.

• 5.3 <u>Recruitment and Promotion</u>

Karuna College of Pharmacy shall recruit such faculty members and researchers who have demonstrable/demonstrated capability in research. Faculty promotion may significantly depend on research undertaken. The quality of research output, especially research publications, may be assessed on the established yardsticks such as Impact Factor (IF) and which will be revised from time-to-time as appropriate.

• 5.4 <u>Research Management</u>

Overall management of research activities may be coordinated by Directorate of Research, Karuna College of Pharmacy under direct supervision of Principal. Research advisory body and administrative committee shall be responsible for overall functioning of research activities within the University. Each department research activities will be coordinated by HOD or the nominations from each department.
